I am aware that roller hockey is a physical, contact sport, and playing roller hockey in the VIHL involves many risks, dangers and hazards including, but not limited to: impact and collision with other players, officials, objects or equipment used in connection with playing roller hockey; changes in the type of surface and the condition of each surface in the building; failure to play safely within one's own ability; failure to play against others of equal stature or ability; theft; negligence of other players; playing with or without officials. I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage, expense and related loss including loss of income, and other loss resulting there from.

I will not hold the VIHL, any VIHL officials, staff, owners, or the proprietor or employees of any facility used by the VIHL, liable for injury that I may sustain while participating in any VIHL activity.

I understand and agree that I am responsible for any and all medical costs arising from any injuries received while participating in any VIHL activities and I am advised to carry medical insurance.

I certify that I have no known medical condition that would prohibit me from playing the sport of inline hockey. I

agree to wear the specified equipment set out in the VIHL rules.

I agree that I will act in a responsible manner in all VIHL activities and abide by the rules of the league. I understand that any behavior that the management of the league deems to be irresponsible or in violation of the league rules, could result in the player's immediate suspension or expulsion.

I agree to reimburse the VIHL, in full within seven days of notice, for the cost of any property damage for which I am held responsible by the VIHL staff or owners.

RELEASE OF LIABILITY AND WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT.

In consideration of the VIHL permitting me to participate in its inline hockey league, permitting me to the use of its equipment and permitting me the use of the facilities, I hereby agree as follows:

- TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the VIHL, and its directors, officers, employees, agents, representatives, assigns and successors.
- 2. TO RELEASE the VIHL, and its directors, officers, employees, agents, representatives, assigns and successors from any and all liability for any loss, damage, injury or expense that I may suffer or that my next of kin may suffer, as a result of my participation in activities and sports offered by the VIHL, due to any cause whatsoever INCLUDING NEGLIGENCE, BREACH OF CONTRACT, BREACH OF STATUTORY DUTY OF CARE, AND/OR BREACH OF THE OCCUPIER'S LIABILITY ACT, R.S.A. 2000, C. O-4, ON THE PART OF the VIHL and its directors, officers, employees, agents, representatives, assigns and successors.
- 3. TO HOLD HARMLESS AND INDEMNIFY the VIHL, and directors, officers, employees, agents, representatives, assigns and successors from any and all liability for any property damage or personal injury to any third party, resulting from my activities and my participation in the activities offered by or associated with the VIHL.
- 4. This Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity.

- This Agreement shall be governed by and interpreted in accordance with the laws of the Province of British Columbia.
- 6. Any litigation involving the parties to this Agreement shall be brought within the Province of British Columbia.

In entering into this Agreement I am not relying upon any oral or written representations or statements made by the Releasees other than what is set forth in this Agreement.

I have read and understand this agreement and I am aware that by signing this agreement I am waiving certain legal rights which I or my heirs, next of kin, executors, administrators, assigns and representatives may have against the VIHL and its directors, officers, employees, agents, representatives, assigns and successors.
