Complaints mounting up in general

- Glaring issue - coaches don't know rules nor application of the rules
 - If player removes helmet in stoppage
 - 1st time gets warning, 10 minute misconduct for equipment infraction(not a 30 day suspension)
- WIHOA is receiving multiple complaints, some complaints are valid, some are not valid
- Does not feel like WIHOA and the officials are supported by UHSH board
- WIHOA is not going to respond to videos any longer - complaints made to Chris directly

- Possible page on UHSH website to ask questions on refs and calls...in the works
- UHSH concern that some refs do not know the rules as well
 - This information can be shared with WIHOA/Chris as well
- Some locations have fewer refs to draw from to work games
- Spectators and people are approaching officials to question them after the game in scoreboard, lobby, hallway - this is not acceptable
- Remind coaches and players not to ask officials what discipline is given for penalties. They are not familiar with UHSH discipline policies
- Spectator should not be in the hallway or hallway area (spectator is a person that is not a coach, penalty box)
 - Parent code of conduct to be resent by the league
- Officials not going to address spectators directly
 - Officials ask scorekeeper to call rink security
 - If no rink security, official to have coach get the parent/spectator out
- 5 and GM if player injured
 - Interference is minor penalty (a few others)
 - If player appears to be injured, a 5 and GM must be called
 - Slashing 2 or 5; a GM must be called if an injury; could be a Match without injury
 - Can call a GM without a Major
- Continuity and consistency is something to strive for
- Ref seminars start in June 2019; hope to be concluded by August 2019
 - Trying to host district level

- D1 Affiliated - 9 teams
- D1 Independent - 7 teams
- D2 - only 1 playoff
- 1st place teams in D1 Affiliated and Independent will not play on Mon, Feb 4th (have bye 1st game) will play Feb 6th
- D2 - 1st, 2nd, 3rd, and 4th place teams will have bye on Mon, Feb 4th and 1st playoff game on Wed, Feb 6th
- Will try to have at least 1 day off between games
- Games will be at various locations when ice is available
