- 4) Treasurer's Report- Phil Pratt (not Peter Diett)
  - -started with 11k, ended with 38k, main reason is we received money from the BC Inline Society, one time fund
  - -other, did receive a large gaming grant, but didn't receive until August so we were cautious with our spending
  - -moving forward with gaming grant, past years just submitting the "short form", but this coming year we have to resubmit the "long form" as per their systems
  - -reduced floor time since numbers were slightly down, did give us some savings
  - -insurance is reasonable this past year
  - -adult league, 6 to 18 teams this past year but did mean increased floor time costs, the profit ended up netting approximately \$0
