## Privacy Policy

### **A Note to Parents, Players and Members:**

The NSIHL website is intended for use by its members.

**Players** - Before sending any information about yourself over the Internet to us or anyone else, be sure to ask your parents for permission.

**Parents** - NSIHL recommends that parents take an active role in their player's use of the Internet. We encourage you to talk to your players about safe and responsible use of their personal information while using the Internet.

### **Your Privacy**

The NSIHL is committed to respecting your Privacy. We recognize that when you provide us with information about yourself, you trust us to act in a responsible manner. That is why we have put a policy in place to protect your personal information. Please read on for more details about our Privacy practices.

### **What personal information does the NSIHL collect? How do we use it?**

At times, we may request that you supply us with personal information. Personal Information means information about an identifiable individual such as name, age, home address, phone number and e-mail address. Information may be requested when you register, take part in a game, or in connection with a League activity or event. This information is required for the operation of the League's activity, event or games.

- When you register, we require your name, your birth date, e-mail address, residence address, telephone number, position preference, limited medical information and in-line hockey playing history. This information is required for insurance and legal purposes and to administer the league.
- When you are attending a League's game, activity or event, we may ask for the player's name, player's number, coach's name, address, telephone number and e-mail address so we can administer the event, submit results, summaries and or details to newspapers, or the League's website.
- The NSIHL intends to continue improving the content and function of our website. For this reason, we may monitor membership traffic patterns and site usage and review membership comments, to help us improve the effectiveness, design, and layout of our site and provide content of interest to our members.

### **How does NSIHL protect membership information?**

The NSIHL collects, uses, discloses and safeguards your personal information only as permitted under BC's Personal Information Protection Act (*PIPA*).

## **What about "cookies?"**

A cookie is a small text file containing a unique identification number that a website sends to your computer's web browser. Cookies enable a site to provide you with service that is more personal. Most web browsers automatically accept cookies, but you can change your browser to prevent that if you would rather not store the information for future use.

## **Will NSIHL disclose the information it collects to outside parties?**

Without the express approval of the elected officers, no mailing lists containing any personal information shall be provided to anyone in or out of the League. The mailing list of the NSIHL is the sole proprietorship of the League and shall be used only for conducting the business of the League. The League may store and disclose personal information as allowed or required by *PIPA*, including making disclosures that are necessary or advisable to: (a) protect the rights and safety of users of our website, the members, the public, NSIHL or our website suppliers; and (b) conform to legal or regulatory requirements.

NSIHL will collect aggregate statistics about our members, traffic patterns, and related site information but these statistics will not include any personally identifying information.

## **Your Consent**

If you do not notify us otherwise, we will consider that you have consented to the collection, use and disclosure of your personal information in accordance with our Privacy practices. If we decide to change our Privacy practices, we will post those changes on this page so that you are kept informed of what data we collect, how we use it, and under what circumstances we disclose it. Please check this page for changes from time to time to make sure you are aware of our latest Privacy practices.

Because the NSIHL operates with other associations and or governing bodies, we make information we gather available to these associations and or governing bodies.

## **Passwords**

In order to bring you more personalized services, we may ask you to establish one or more passwords to gain access to certain services or sections in either the NSIHL website or the website(s) of other suppliers whose products, events or services are available for you via a link from our website. You are solely responsible for the control and use of each password you create.

## **Links to other sites**

Our website contains links to other websites. Please be aware that privacy policies vary from site to site. We are not responsible for the privacy practices of other websites to which our site may link.
