



## FORM - ADULT | INTERNATIONAL TRANSFER CERTIFICATE (ITC) 18+

Criteria for this international clearance:

- Player is 18 years of age or older at the time of registration
- Player last participated in organized soccer with a club/team/league outside of the United States, regardless of citizenship.

## FIFA REQUIRED DOCUMENTS

- **ONE (1)** Proof of Nationality document is required and limited to:
  - Passport
  - Visa
  - Permanent Resident Card

## SUBMISSION INSTRUCTIONS

- Submit electronically in **ONE (1)** email to - [player\\_registration@ussoccer.org](mailto:player_registration@ussoccer.org)
- Copy all persons as requested/required by local club, league, team
- Subject line should read - ITC 18+ / PLAYER NAME
- Submit the following in PDF format and no larger than 5MB
  - Completed 18+ ITC Request Form
  - And FIFA required documents
- Attach each document separately to **ONE (1)** email
- Submit at least 30 days<sup>1</sup> prior to start of league

## FORM INSTRUCTIONS

- All fields required for processing
- Information should be current and accurate
- Type or print clearly

Applications with missing, incomplete, inaccurate/wrong information, improper formatting will not be considered for review and applicant will be required to resubmit for processing.

The Player Status Department will contact applicants to provide updates on applications when available and/or required.

Due to the high volume of applications received, kindly refrain from submitting emails requesting status updates as those specific requests will not receive a response. Thank you in advance for your adherence to the above instructions and cooperation.

In accordance with FIFA's Regulations, all amateur ITC requests must be submitted into FIFA TMS by U.S. Soccer once we receive the completed form and all supporting documents. If the player has never been entered into the system, the releasing federation must confirm the player's details prior to U.S. Soccer being permitted to request the ITC. Please note U.S. Soccer has no control over the timeline of this process as this is the sole responsibility of the releasing federation. Once a player is confirmed in FIFA TMS, U.S. Soccer will request the ITC accordingly.

Once Player Status requests the player's ITC, we will update whoever submitted the application at which time the releasing federation has seven (7) days to respond Player Status request. If the releasing federation does not respond, on the 8<sup>th</sup> day FIFA TMS will then provide Player Status the option to record a provisional clearance. Please note if there is any incorrect information within this form, Player Status has to resubmit the ITC with the correct information which starts the provisional clock over again.
