THIS RELEASE AND WAIVER OF LIABILITY AND INDEMNITY ("Release") is effective December 1, 2021 by the individual completing this online registration, together with his or her heirs, executors, administrators, successors and assigns (collectively, "Participant") in favor of Campbell Sports, Inc., an Illinois corporation ("Campbell Sports").

NOW, THEREFORE, for Participant's participation in the hockey league, club, camp, or clinic, ONE AND NO/100 DOLLARS (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Participant, Participant, intending to be legally bound, hereby agrees as follows:

- 1. Participant hereby releases, waives, discharges and covenants not to sue Campbell Sports or any of the respective stockholders, directors, officers, employees, attorneys, agents and affiliates of each (collectively, the "Indemnified Parties"), from all liability to Participant, his/her personal representatives, assigns, heirs and next of kin for any and all loss or damage, bodily injury or otherwise, and any claim or demands therefor on account of the Indemnified Parties or otherwise while Participant is in or upon any property where Participant engages in the sport of hockey ("Sport") organized by Campbell Sports, including hockey rinks, and/or competing, officiating, coaching, observing, working for, or for any purpose participating in the Sport ("Field of Play").
- 2. Participant hereby agrees to indemnify and save and hold harmless the Indemnified Parties and each of them for any loss, liability, damage or cost they may incur due to the presence of Participant in or upon the Field of Play, or in any way competing, officiating, observing, working for, or for any purpose participating in the Sport and whether caused by the negligence or gross negligence of the Indemnified Parties or otherwise.

- 3. Participant hereby assumes full responsibility for any risk of bodily injury, death or property damage due to the negligence or gross negligence of the Indemnified Parties or otherwise while in or upon the Field of Play and/or while competing, officiating, observing, working for, or for any purpose participating in the Sport.
- 4. Participant hereby acknowledges that the Sport is a dangerous sport that can lead to serious injury, or even death. Participant hereby understands and agrees to personally assume any and all of the liability and risks of the Sport. Participant represents and warrants that Participant is in good physical condition and is able to engage in the Sport without compromising Participant's state of health. Participant agrees to use good judgment while engaging in the Sport and will engage in the Sport at Releasor's own pace and at Participant's own risk. Participant accepts full and complete responsibility for the safety of his or herself, any guests or observers accompanying him or her or present at his or her invitation, and his or her personal property. Further, Participant assumes the risk of any and all damage to persons or property caused by his or her intentional or negligent actions.
- 5. It is Participant's express intent that this Release shall bind the members of Participant's family and spouse, if Participant is alive, and Participant's heirs, assigns and personal representatives, if Participant is deceased, and shall be deemed as a release, waiver, discharge and covenant not to sue Indemnified Parties.
- 6. Participant agrees that he/she has been given sufficient time to read, understand, and ask questions, if any, concerning the nature and scope of this Release and understands that Participant is giving up substantial rights, including the right to sue. Participant acknowledges that this agreement is being signed freely, voluntarily, and without duress and Participant intends the signature below to be a complete and unconditional release of all liability to the greatest extent allowed by law. The terms of this Release shall be construed as the entire agreement and may not be altered, amended, or modified except in a writing signed by Releasor and Releasees. The terms of this Release shall be governed by the laws of the State of Illinois.
- 7. Infectious Diseases: Participant acknowledges the contagious nature of COVID-19 and other infectious diseases, and voluntarily assumes the risk that they may be exposed to or infected by COVID-19 or other infectious diseases by use of the property, facilities, services, and/or programs facilitated by Campbell Sports and that such exposure or infection may result in personal injury, illness, permanent disability, and death. Participant understands that the risk of becoming exposed to or infected by COVID-19 or other infectious diseases at, or on the premises of facilities where Campbell Sports hosts activities may result from the actions, omissions, or negligence of themselves and others, including, but not limited to, Campbell Sports and its officers, directors, employees, agents, representatives, volunteers, and program participants and their families. Participant voluntarily agrees to assume all of the foregoing risks and accepts sole

responsibility for any injury to themselves (including, but not limited to, personal injury, disability, and death) illness, damage, loss, claim, liability, or expense, of any kind, that they may experience or incur in connection with the services provided by Campbell Sports or participation in Campbell Sports programs ("Claims"). Participant hereby releases, covenants not to sue, discharges, and holds harmless Campbell Sports and their officers, directors, employees, agents and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. Participant agrees that this release includes any Claims based on the actions, omissions, or negligence of Campbell Sports, their officers, directors, employees, agents and representatives, whether an infection due to COVID-19 or other infectious disease occurs before, during, or after participation in the services provided by Campbell Sports or use of the property, facilities, services, and/or programs of Campbell Sports.
