Chair Report:

Field Directorate Update

- Distributed Field Provincial Directives for U11 Youth, U13-U19 Youth and Women. In the process of being finalized this week and will be distributed once final.
- Finalized all Tiers declared teams. 84 PCFLL teams declared 63 youth and 21 women's
- High School discussing going to 6s but no solid plans or timelines at this time.
- Coming out of the LMMLC AGM, I also recommended that the FD and the MD cooperate on rules and enforcement of residency since several of our clubs govern both Field and Box together. The Interior

league has policy that uses School District as the determining factor if there's an issue with the registration. The club located in the district the child attends is the club that the player needs to register with. They have seen success with the number of disputes dropping over the past few years. I will be reviewing this policy / by-law to see if it is something that is workable for the PCFLL.

LMMLC AGM

- Using Arbiter to assign officials but it was not smooth. Questions around continuing with it. (of note: PCFLL moves so many games around from the tentative schedule that the use case for an assignment software is not strong at this time.)
- Residency disputes \$1000 to clubs found not to be doing due diligence.
 - Should be noted that there was a lot of discussion around residency rules and enforcement and frustration from clubs and exec on what tools can be used to enforce policy.
 - o Consensus was to ensure that clubs are doing due diligence.
- Almost unanimous vote to reset standings to zero after Tiering is complete. Several mentions of field already doing this and kudo to our group
- Player fees are \$2 and \$25 per team the fees were \$35 for the last few years.





Tiebreakers for Playoff and Playdown Seeding

- F.03. Standings
- a) League play standings shall be determined as follows:
- 1. Highest winning percentage
- 2. if tied, then most wins
- 3. if tied, then most ties
- 4. if tied, then fewest games played
- 5. if tied, then Least Goals Against
- 6. if tied, then Coin Toss

Contingencies for Games that Cannot be Played - 2023/24

Teams may request a reschedule as per the timelines in the PCFLL Operating Policy.

The game can be played at any point until the immediately following Tuesday or the requesting team must forfeit the game to their opponent. Since Playoffs are an elimination format, the league needs a winner by Tuesday in order to schedule the following week.

If a game is postponed by the League, efforts will be made to reschedule the game for as soon as possible, up to and including the following Sunday if time permits (where all games are cancelled in a weekend). Decisions to reschedule or declare the game cancelled are at the sole discretion of PCFLL Executive personnel.

If the League determines any game or games must be cancelled in order to facilitate completion of the Playoffs, the winning team for the matchup shall be the team with the:

- 1. Most wins, all teams' games in Fall Schedule only (no playoffs, tournaments, or tiering);
- 2. If tied: Fewest losses, all teams' games in Fall Schedule only (no playoffs, tournaments, or tiering);
- 3. If tied: Head to head record Fall Schedule only (no playoffs, tournaments, or tiering);
- 4. If tied: BCLA Goal Formula Head to head Fall Schedule only (no playoffs, tournaments, or tiering);
- 5. If tied: Least goals against Fall Schedule only (no playoffs, tournaments, or tiering); and then
- 6. If tied: Commissioner coin flip

DISCUSSION- Contingencies for Games that Cannot be Played - 2022/23

If teams do not have enough players to field a team, they may request a reschedule as per the timelines in the PCFLL Operating Policy. However, the game must be played by the immediately following Tuesday or the requesting team must forfeit the game to their opponent. Since Playoffs are an elimination format, the league needs a winner by Tuesday in order to schedule the following week. If a game is postponed by the League in the following conditions, efforts will be made to reschedule the game for as soon as possible, up to and including the following Sunday if time permits:

- A game is postponed by the League or Commissioner (local field safety, weather, or officials); or
- All games for a Pool are cancelled in a weekend.

Any and all League rescheduled games are at the sole discretion of PCFLL Executive personnel.

If the League determines any game or games must be cancelled in order to facilitate completion of the Playoffs, this formula, in listed order, will be used to determine the winning team for the matchup. The Winning team will be the:

- 1. Winner of season head to head series for League games only will include Tiering Schedule but will not include tournament and will not include exhibition;
- 2. If 1. is tied; BCLA Goal Average Formula for all League games played head to head series (again, only League games are used, no tournament or exhibition games will be used unless the tournament game was officially a league game as per the Commissioner);
- 3. If still tied, seeding at the conclusion of Fall Schedule; and then
- 4. If still tied, Commissioner coin flip.
