Head Referee:

- U9 has the last 2 mins of stop time but the other divisions do not have it. Need it more at the older competitive levels
 - Will be discussed at the Field Directorate meeting this evening so hopefully can be implemented at the U13-U18 levels
- No change of ends during the game
- Initial possession after the coin toss will be at center with everyone 5 yards away from the ball carrier
- Home team will always be to the left of the score table if you are looking at the field
- Game fees on the PCFLL website. Please make sure that you are paying your travel fees
 - Jody will notify all teams directly when they need to pay travel fees
- Electronic whistles still not in. For now, refs will have to use manual whistle with gauze over the blow hole to eliminate spray
- Only 3 rule changes: no face-offs; when a goal is scored, ball will start 20 yards straight out, loose ball rule
 - Ref association has asked to get rid of the loose ball rule. No point in stopping for a loose ball when the rest of the game is normal
 - Younger divisions will be nothing but whistles as the ball is on the ground a lot

 22 people all together

- Jody mentions that they were not able to give rule books to the new referees as the course was online.

 - Jody will look into and forward info to Tyler
