PCFLL EXECUTIVE REPORTS



PCFLL Chair Report 2021/2022

The PCFLL was proud to offer a full season to over 2000 Youth and Women field lacrosse players starting in September 2021 even with profound challenges that could not be anticipated headed into the season.

Registration numbers were strong with 1624 Youth players and 456 Women players - this is comparable with our last full season in 2019/20.

The PCFLL made necessary pivots during the season to deal with travel and fuel restrictions as well as dealing with ongoing Covid protocols for outdoor sports. Member associations worked cooperatively during the season to ensure players were taking to the fields and also stepped up financially for our officials supporting mentoring hours so senior officials were compensated for supervising and mentoring our newest and youngest officials.

While the season was successful overall the League faced several specific challenges:

- Overall Covid protocols during the regular season were challenging but manageable by member Associations. While the Omicron variant posed issues with personnel attending games (players, officials, coaches), the outdoor Covid protocols remained fairly stable until the tournament ban was announced in early 2022 potentially impacting Provincials and League Jamborees.
- 2. The largest impact outside Covid were the devastating floods in the Fraser Valley in late November 2021.
 - The resulting travel and fuel restrictions were taken into account by the PCFLL and a regional matchup schedule was put into place for two weeks so as to respect the spirit of the restrictions and acknowledge what our lacrosse families and communities were going through that lived close to the flooded areas.
- 3. On the Women's side, while participation is strong across the three other age groups, U19 continues to be a struggle in terms of playing and practicing. From Stacy Paterson, 2nd Vice Chair, Women's Coordinator:
 - This season there were 3 U19 teams from PCFLL Adanacs, New Westminster, Surrey
 - There were no Provincials for this age group. We still continue to experience ongoing challenges with fielding U19 teams that have adequate player commitment, even with rosters of close to 20 players, to keep the teams going through the season. One of the challenges were the Club field times that they were allocated by Parks & Rec in their municipality, making it difficult for players to play and then have to race to a game to officiate / coach or vice versa. Coaches also expressed concern about the players still committing to practices as well as games on the weekend, as well as injuries, which no one has control over.
- 4. Youth Field Lacrosse faces challenges from private clubs and at U18 where tiering is difficult. This year there were four U18 teams and only three declared for provincials. Preventing loss of players from U15 to the final year of U18 will be crucial to this division's success in the upcoming years.

On the positive side the PCFLL had several small victories this year to set up for future success:

- 1. The PCFLL established four working committees to make improvements for next season and beyond. They are:
 - a. Operations Committee to improve game day and pre-season activity such as tiering and releases;
 - b. Officials Committee to improve recruitment and retention of officials;
 - c. Policy Committee to improve the consistency of policy amendments and the overall Operating Policy of the League; and
 - d. Anti-Harassment Committee to address bullying and harassment incidents that unfortunately are still a part of our environment.
- 2. A great example of the spirit of Lacrosse was after the Richmond Romp tournament. Several Interior teams attended, however, travel was then impacted after the tournament concluded. Several Lacrosse families within the PCFLL stepped up to help drive or house stranded families while alternate travel arrangements were made. A spreadsheet was circulated for needs and resources and thankfully everyone was able to make it home safely. The effort, coordinated so quickly, and without anyone being asked to do so, was another shining example of how this community can come together quickly when needed.
- As part of Operational improvements prior to the season, deadlines for release requests
 were put in place so that Associations and families had visibility into when the League
 was going to make decisions. The League was then able to move players more
 efficiently.
- 4. Communication from the League improved this season and an online form software was introduced allowing for the League to collect information from Associations in a more standardized way. This allows the Executive volunteers to utilize their time more effectively. We are still searching for a better way to ensure that information and decisions by the Associations in the League and / or the League Executive is communicated to the Coaches and Managers who the decisions usually impact. It feels like the "club rep" model could work more effectively to disseminate information and the League will continue to attempt to improve in this area.
- 5. The league game schedule is very dependent on the number of officials and the age groups those officials are rated for. Angie Wolfe and Stacy Paterson worked closely with Susan and Angie (Reid) to move games so that they could be played and not cancelled based on officials availability. The PCFLL did not have enough officials to ensure that there were officials available for every game, every week, and several games throughout the season needed to be rescheduled due to this. The PCFLL wants to be in a position where this movement is not required, but until then, this collaboration and hard work is required in order to field as many games as we can each week.

Staying with officials, our officials community deserves huge kudos this season. Angie Reid and Susan dos Santos went above and beyond the normal expectations of Assignors to ensure that the most games could be played every weekend. officials were asked to travel more and in the case of our senior officials they were also asked to mentor new officials. This meant arriving extra early or staying after their own game to supervise. Keeping officials is more difficult than

recruiting them in the first place. While the PCFLL was able to step up financially to ensure mentoring was available, our parents, players, and coaches have some responsibility here to keep the abuse of officials to a minimum. Senior officials have choices in how to spend their free time and they choose to spend it supporting our League. We need to respond in kind. This does not mean that officials who require improvement should not receive it or that officials are beyond reproach. However, we need to understand that lacrosse is a fast-moving game and officials should not be expected to be perfect - and they should not face abuse from other participants or fans if they aren't.

On a personal note I would like to thank the Associations and the League Executive for the long hours required to make this season successful. Both groups demonstrated a community spirit and cooperation that made it possible to play the amount of games we were able to this year. We also attempted several changes this year and some were improvements over how we did things and some were not. However, the willingness to try changes is how we progress our League and the Creator's game. I look forward to preparing for next season and the challenges that lie ahead.

Perhaps a change in format (U19s play Sixes) and the possibility of weeknight games during what would have traditionally been practice times, will be an improvement. Something to explore!

The Big Al's 7v7 tournament was held in Coquitlam again this year, U12, U15 & U19 teams in attendance, with the U8 teams having a Jamboree on the Saturday. This year's tournament was again a 2 day event with games being played on Friday night & all day Saturday. Thanks again to Dennis Santucci & the Adanacs for organizing this annual event that is highly anticipated by players, parents & coaches. For the 2022-2023 season, we would like to propose that the Big Al tourney is the opening weekend of lacrosse for Women's teams.

Thanks again, and always, to Angie Reid for being SO easy to work with when it came to scheduling games & ensuring that we had enough umpires to cover the games.

Provincials went off smoothly for the U12 & U15 Divisions and the weather was on our side for most of it.

Good luck to all the graduating players! Wish you all success in your future lacrosse endeavours.

Pacific Coast Field Referee Allocator Report 2021/2022

2021/2022 is a season to be remembered by all of us. Whether we remember games played or refereed during the 16 weeks of league play, 3 large multi level tournaments, 1 U7 Jamboree, a U11 Final tournament and the U13/15/18 Provincials, or we remember the myriad of natural phenomenon that descended on the Lower Mainland or we remember the ongoing, every fluctuating, pandemic related restrictions and precautions, one thing is certain, 2021/2022 will not be forgotten.

A small and mighty crew of referees covered an average of 42 games a week for a total of over 650 games this season from fields in North Van to Lander to Chilliwack and Mission. To get to these games, hundreds of kms were driven. To parents, who drove the younger referees, I say "thank you" for supporting your youth in their growing skills as a referee and helping to ensure games were played; to referees who drove the distances and often dashed between fields in order to ensure games were covered, I say "thank you" for serving the teams and especially for your efforts to get to those games played at the the farther distanced fields.

To the new referees who joined the ranks, we are glad you decided to learn to referee. We also hope each one of you learned lots and will return to continue developing your skills as a referee next season.

To the referees who have been a referee for a few years or a long time, thank you to each and every one of you. Without you, the games would not have gone ahead this season. To those who helped mentor, thank you for investing in the development of the younger referees.

It was my desire when I was asked to take on this role to see the field allocation move to an online system but it quickly became apparent that we do not have sufficient referees for this to work effectively. So I used google docs both for referee allocation and collection of availability. This allowed for a good overview of the schedule each week and visual ability to see where we had gaps. The referees were sent a reminder weekly to update their availability and then I worked to schedule them. Unfortunately, a 40/60 situation occurred, where about 40% of the referees were prompt to input their availability and quick to notify me if things changed, and about 60% I had to send reminder emails and/or text or even call to find out their availability. In a world with more referees, these referees would simply have not gotten games, but in a world where we needed every single available referee every single weekend, I simply had to reach out and know the availability of each referee. This procurement of availability took up hours each week and was a consistent thought in my mind.

I recognized that the referees are giving up a large chunk of their time each Sunday and so I sought to get the schedule out each week as early as possible. It was my goal to have it out by Thursday night, if not earlier; though this was not always feasible between the crazy weather, ref availability and other factors. Next year I would really like to try to get the schedule out even earlier in the week, but some of the referees work in the hospitality and service industry and do not receive their work schedules until Wednesday or Thursday for the week ahead (which starts on Sunday) which complicates the scheduling. To say it takes hours to put together the referee schedule each week is an understatement. It is a detailed and intricate puzzle with many moving parts and as soon as one change is made it creates a domino cascade as one has to to consider level of the game/referee, schedule/availability of the referee (often considering their own game played or coached), distance between fields and, as the season goes on, conflict between certain coaches and referees. It is a challenge that is reset to a blank page each week. Additionally, scheduling referees often required last minute Sunday shufflings and many weeks I was woken early in the morning to the news of a referee who was injured or suddenly ill.

Several local associations have local allocators for the U7/9/11 age groups and their work at assigning referees for those games is most appreciated. Moving forward it would be helpful if all local allocators communicated their assignments to the PCFLL referee allocator so that if game schedules of the referees who also play do not work to have them referee home games then we can collaborate to get them level appropriate games on other fields as well as development of the younger referees can be incorporated into the assignment of the older referees. Without local Head Referees in most associations it is essential that we do some more mentoring of the younger referees and to do this, we need to know who is scheduled on which games.

Mentoring of referees took a front seat this season and I know from referees and coaches that this focus was appreciated and has yielded good results. While we had some referees doing some volunteer mentoring by arriving a bit early for their own game early in the season, it was at the Langley tournament that we started to implement some more formal and intentional mentoring. Seeing how effective it was, it was very much appreciated that the PCFLL approved a total of \$4,000 that we could invest in mentoring the referee. This enabled us to have mentors at 48 regular league games where they could help nurture the younger referees. In addition, 46 games at the Richmond Tournament had intentional mentoring or focused referee development. At the Richmond tournament, we tried some new things like having new referees shadow some older referees, and on field mentoring support, as well as more formal mentoring/evaluations. We tried a U7/9 league day in conjunction with the tournament and while this meant that the referees who attended got some excellent input, there were some hiccups in communication with teams and expectations that teams would travel out to Richmond. While we focused on the U7/U9/U11 referees for their foundational development, it was also exciting to be able to support some of the older referees in their development. We saw 4 more referees learn the 3-referee system at the Richmond Tournament and 2 referees learn how to mentor at the U7 Jamboree. We saw 5 referees develop in their mentoring skills at the U11 Tournament and 10 referees work on or learn the 3-referee system at the U13/15/18 Provincials as well as 4 referees introduced to the CBO position at the U11 Tournament. To the Senior Referees who served as the mentors - thank you! Your willingness to impart wisdom and help train the new referees is most appreciated. To PCFLL, and member associations, thank you for believing in me to organize this mentoring and for investing in the referees. I hope we can continue to see this support for the referee mentorship program next season.

In addition to regular weekly league play, this season saw several additional events:

- 3 Large Tournaments Maple Ridge (70 games), Langley (100 games) and Richmond (100 games) kept the referees (and me) extra busy on those weekends. I am grateful that the PCFLL league agreed to cancel league games on the November weekend of the Richmond tournament as by mid November the referees were showing exhaustion and there is no way we could have covered the league games in addition to the tournament games that weekend. A careful analysis of which weekends have tournaments next season and an intentional spreading out (vs back to back) will be necessary to not further burnout the referees. Perhaps the Tiering break weekend can be used for a tournament. Additionally, out of town experienced referees should be invited to all 3 tournaments to help share the load.
- U7 Jamboree was an exciting opportunity for 10 new and developing referees to not only referee some games but also have experienced referees specifically present and prepared to provide developmental feedback where they could then seek to apply this feedback in their very next game. Thank you to Joe who RIC this event and Matt and Austin who assisted with the mentoring and instruction. Thank you to Megan who put together a good schedule and worked to find a new time when weather and then COVID restrictions forced dual postponement of the Jamboree.
- U11 Tournament had to change its date due to the COVID restrictions and this created a challenge as several of the level appropriate referees were no longer available due to March Break holiday plans. Continuing the theme of development of referees, we were able to bring in 7 experienced referees to intentionally mentor the younger referees. We created an evaluation sheet specific to Level 1 referees and I know the referees appreciated the feedback and takeaways for improvement. It was good to see 'college' referees investing in the younger referees and learning how to give constructive feedback.

A big step, especially in light of gas prices and in recognition of the fact that every weekend we were seeing multiple referees out of their 'home base', was to update the travel allotment. I know the referees are grateful that we saw the PCFLL membership agree to increase to \$15 if they had to travel 20+kms to a field. This distance was measured from their home address to the field. Payment was made by the home association and paid once per ref per field regardless of the number of games they did at that field that day. The administration of this was labour intensive and took an average 2 hours each weekend as I had to look up each referee and calculate distance for every game and then email

each manager and advise them. I would love to see this centrally tallied and paid out at the end of the seasons (tiering/fall/winter) rather than weekly at the field.

Many of the game cancellations (once referees were scheduled) could be attributed to the crazy weather and/or COVID impacting a team. The referees were gracious in understanding this and even when there were last minute cancellations, I did not have referees asking to be paid. A few games were canceled for other reasons and I was able to ensure the referees were paid. However, a system needs to be created to track the cancellations and ensure referees are paid. Currently, while the league may fine a team, it is the team who needs to pay the referees and there is no mechanism to know when that has been completed.

Unfortunately there were numerous games canceled due to a lack of available referees. This impacted all divisions and was not limited to just the older U15/U18 age groups. With only 10 level 3+ referees regularly available and 15 'college' age referees (some of whom also coached or played) we had challenges covering the older divisions. We also had issues in the middle as there were only 7 referees ready to do U13 and all but one were also playing and some also coaching so frequently not available to referee a game. There is a good group of 14 referees who have now reached the U11 level and with the investment of mentoring this season we have seen them take steps forward in their development and it is my hope that they will all return and continue to referee. There was also a decent "entry level" group this year - while some did not get very many games, I truly hope they have had a positive experience and taste of what they can do as a referee and will return next season.

It was a pleasure to lead the PCFLL Committee re Referees. I thank each member who was assigned or chose to join the committee: Angie, Dave, Trevor, Joe and Dennis. You each brought something to the discussion and it was evident this was an area of passion when our first meeting generated 4 pages of notes in just over an hour. Our focus was to address the areas of Recruitment, Retention, Optimizing Training, Mentorship and Travel Fees. We summarized and grouped many excellent ideas into a chart report that will be made available to all member associations as well as PCFLL, BCLA and BCLOG in the hopes of assisting in addressing these areas. Looking forward it is my sincere hope that some of the ideas the PCFLL Committee re Referees came up with will help to ensure continued support and development for the referees as well as develop a larger pool. Without an expansion of referees we will soon be in a deep pickle.

As I look back over the season, I can say it was a crazy and intense 7 months. Jumping in with no orientation (and at the start, not even a list of names of referees or indication of their level or location) was not easy but I am thankful to all for the support and especially to a few who helped me figure things out at the beginning. I am indebted to Angie Wolfe her assistance to help me consider logistics as well as her willingness to let me provide input on the schedule over the whole season was very helpful in the whole jigsaw puzzling. In addition, I am thankful for Ryan Nose and a couple of Senior referees who were willing to help me sort out the weekly 'Jenga' Puzzles while I learned the ropes and the skill levels of the referees. Your assistance kept me sane in a myriad of confusion and helped ensure we had referees on as many games as possible each week.

To each of the referees who accepted games and went to referee - Thank you!

PCFLL Women's Field – Head Umpire/Women's Vice Chair Field Officials Report

In the 2021/2022 season, we saw some great successes and some of the same obstacles we have faced in previous years.

Just a week after start of the season, associations participated in the 7v7 tournament hosted by Coquitlam. A huge thank you to all who helped make this tournament happen. It provided the opportunity for former and brand-new umpires to get out there. Some officials did not have much of an opportunity in the previous season, so this was a great start. It might be a great idea to have the 7v7 tournament start the Women's field season instead of after a week or two of league play.

Another great opportunity was the Langley Thunderstrike Tournament. This was the first year the Women's Field game was incorporated and it was a huge success. I was able to provide mentorship and have many new umpires shadow and gain more confidence for the rest of the season. I hope we can continue to be a part of this in years to come.

I also had a mentorship budget provided to me by the PCFLL which helped with over 25 different mentorship opportunities during the fall/winter season. These funds made it possible for experienced umpires to support newer, less experienced officials and provide them the confidence to continue officiating.

This season, we had 44 umpires take online umpire course, 43 completed their certification, with only one official who did not complete their on-field portion (so were not fully certified). This was a lower number than in previous years which was expected considering all that happened with Covid the previous season. Out of those officials, there were only 5 Level 2 officials, which made allocating the U19 and some U15 games difficult. With the course also being online, it makes it difficult to engage new officials, so hopefully we will be back to in person and on field next season.

We have had a couple adults sign up to officiate and it continues to prove successful. I would encourage associations to continue to recruit adults as well youth to umpire next seasons. With many U19 and U15 officials moving on to university or other endeavours, we are going to need as many as we can get. My hope is we can continue to recruit adults so they can eventually mentor new umpires in years to come.

The scheduling of umpires was reverted back to central allocation, which made allocating much easier, even if it did add to my plate. Having associations with field times on Saturday mornings made it difficult to have some of the new officials umpire games because they were either playing or coaching.

The U19 division proved difficult once again this year. With fewer level 2 officials and waning interest, it was frustrating for everyone. I do know there have been many ideas suggested, so hopefully we can find some success next season.

This season, we were at last able to host Women's field Provincials, which proved to be a great success. We were able to run the 3-person system for the crossover and medal games as well. Thank you so much to Ridge Meadows for hosting this year.

My recommendations for this next season would be as follows:

- This season for clinics, I would like to move back to in person and have the afternoon be on field as it was in previous years. It helps the umpires put into practice what they have learned in class.
- Associations continue to recruit more adults as well as youth starting in early August (especially since all umpires must be certified (or recertified) by November 11th of the playing season. This would include recruiting back those officials back from university.
- Continue with on field mentorship of newer officials and officially evaluating umpires for continued improvement.

Issues

- 2. At least one player was not eligible for provincials for insufficient games. Despite a doctor's note and communication between coach and myself, she was denied playing. This was very disappointing, particularly at the U12 Tier 2 level. Growing the game and encouraging participation should be the focus at this level.

Conclusion

It was a successful return to play and teams were understanding of COVID changes and challenges. Consideration to tiering next season may be appropriate.

PCFLL U9 Age Group 2021-22 Season Summary

During the 2021-22 Field Lacrosse season, we had 11 teams (21 last season) from 9 Associations; with only two associations (6 last season) having two or more teams. This was a notable decline from the past several years and most likely attributed to COVID related factors:

- Coquitlam (2)
- New Westminster (1)
- Ridge Meadows (2)
- Burnaby (1)
- Delta (1)
- Langley (1)
- Port Coquitlam (1)
- Vancouver (0)
- Mission (1)
- Surrey (0)
- Chilliwack (1)
- Richmond (0)
- North Vancouver (0)
- Valley (0)

For the most part the majority of the teams were in the 10 to 15 players in size, there were very few teams with 16 or more players. The season began as per usual with coaches and referees getting used to the U9 incidental contact rules, while this is typical it appeared that the degree of contact occurring was higher than normally noted in past seasons despite numerous reminders being sent out to teams in the early part of the season. This appeared to be due at least in part to referee related issues such as: referee lack of clarity on the degree of contact permitted at U9 and the lack of early season mentoring of young and new inexperienced U9 referees. This issue was brought up with the league and quickly remedied through mentoring actions taken during the Richmond tournament, thereafter the number of contact issues decreased and the number of contact penalty calls increased initially (i.e., as it should until players and coaches understand fully what is permitted). This highlights how important in U9 it is to make sure at the beginning of the season that referees clearly understand the amount of contact permitted and that the intensive mentoring of new and inexperienced referees must occur in the first few weeks of the season. At this young age excessive contact can result in injuries and result in players quitting so it is important that it is dealt with quickly. There were no suspendable infractions to any players or coaches during the season this year.

Despite the smaller number of teams the team strength spread was typical of a normal season with 3-4 teams being very strong, 3-4 teams average and a couple of teams being very weak. For the most part the games were relatively competitive, while some informal tiering was done to try and avoid lob-sided match ups the smaller number of teams made it difficult to avoid them from time to time. The number of blow out scores (which did not always reflect the competiveness of the game) this season was not excessive. No major issues were noted with regard to multiple team balancing and where issues did exist it appeared to be related to

player absenteeism (i.e. conflict with other sports) and inexperienced coaching. I was satisfied the Associations involved made every effort to try and remedy these issues.

As to the week to week housekeeping issues with this Division the main one was game sheets, while game sheets were always provided in a timely matter there was one item in particular that appears to be difficult to solve: **Score Sheet Quality**. The quality of the score sheets was for the most part ok, but there were still issues around the filling out of the sheet, which is to be expected when you are dealing with parents and coaches that are generally new to field lacrosse. There should be more direction from the referees and oversight from managers in assisting score keepers to fill out the game sheets properly (although I am pretty certain that some of the referees and managers at this level didn't know how to fill it out either). Although a copy of a properly filled out game sheet was sent out to teams and Associations it was likely never regularly made available at the field. The managers were also referred as well to the tutorial provided on the PCFLL website in hopes this would be passed on to parents; this did help in some cases.

All other season issues were typically weather or COVID related. Hopefully we can see a return to an "End of the Season Jamboree" and U9 inclusion in tournament play next season.

I was troubled by the amount of discipline that I had to deal with this year at this level. There were a few fights and some unacceptable hits that were not predominant in previous years. I am hoping it was due to not being engaged in lacrosse activities as much the previous year and will adjust for next season

The teams were very good at getting their game sheets in on time after the games via email or text. There were a few associations that I had to wait on for actual physical copies to come in, it was predominately the same teams each week that were late.

I had a great time with this group of managers as new manager to the game they were all very devoted to ensuring that the season ran smoothly for their teams and worked well to ensure any reschedules were accommodated promptly.

CURRENT REGULATIONS

F.01 Playing Season

The playing season may start as early as the first (1st) weekend after Labour Day and may continue as late as the final weekend in March of the following year. All PCFLL scheduled and rescheduled games between the start of the season and the following five (5) scheduled weekends will be considered Tiering games, which count towards league play. The following weekend will be a tiering break. The Regular fall season begins the weekend following the last Tiering break and continues until mid-December. A winter break will run from mid-December until early January of the following year. The regular winter season begins in early January and may continue until the final weekend in March. The Winter Season shall be a continuation of the Fall Season. All teams will continue to play each other, regardless of provincial declarations, with every effort made to have a balanced schedule.

At the start of the playing season the PCFLL Executive will place teams in the appropriate tiers best suited to each team's level of play. Clubs may request in writing any changes to their teams starting tier prior to the creation of the fall and winter schedule. The PCFLL Executive will review any requests and place teams in the tier best suited to each team's level of play.

PROPOSED NEW REGULATIONS

F.01 Playing Season

The Playing Season will run from as early as first weekend in September (after Labour Day) until at the latest the final weekend in March of the following year

The Playing Season will be divided into three segments:

Tiering Schedule

Fall Schedule

Winter Schedule

All league scheduled games in the Playing Season will count toward final standings.

The League Executive will establish a Tiering Schedule of up to no more than five weeks at the start of the season.

A one weekend break may follow the final week of the Tiering Schedule (Tiering Break) occur in tiered divisions to allow for team movement.

The Fall Schedule shall begin and end on dates set by the league Executive. Fall Schedule will begin after Tiering Break and / or Tiering Season and continue until no later than the final weekend in December.

The Winter Schedule shall begin and end on dates set by the league Executive. Winter Schedule will begin no earlier than the first weekend of January and continue until no later than the final weekend of March.

Teams will continue to play in tiered position regardless of provincial declarations Every effort will be made to have a balanced schedule.

RATIONALE

No significant policy changes here.

Deconstructs the large paragraph of information regarding the playing season breakdown. Clarifies the names of the season and allows the executive and league more flexibility in setting the starts and ends of each based on need. Allows the option of tiering break if needed, rather than requiring.

F.03. Points

League play points shall be determined as follows:

- a) 2 points for a win 1 point awarded to each team for a tie 0 points for a loss
- b) In the event of a defaulted game, the non-offending team shall be awarded a goal and shall be awarded 2 points in league standings.
- c) The offending team shall be fined \$100.00 if the offending team cancels a game within 96 hours of the scheduled start time (or \$200.00 if less than 24 hours' notice of forfeiture) payable to the PCFLL. The non-offending team shall be awarded 2 points. Costs associated with the game (i.e. referee fees, field cost) will be paid by the offending team. The game expenses will be paid to the non-offending association/club within thirty (30) days of the receipts received.
- d) Any team who plays an ineligible player will lose points, if they win. The points will be awarded to the non-offending team. The coach of the offending team will face a suspension, as stated in the suspension guidelines.
- e) Any team found guilty of playing an unregistered player during a regularly scheduled game (league, tournament, exhibition and provincial) shall forfeit all games won during which said player was a participant. The home association will be fined \$250 (payable to the PCFLL) if a player has played is found to be unregistered, defined as registered in the BCLA player database and all required, completed registration forms in the hands of the League Registrar (prior to Oct 31 deadline) or BCLA Registrar.

PROPOSED AMENDED REGULATIONS

F.03. Standings

- a) League play standings shall be determined as follows:
 - 1. Highest winning percentage
 - 2. if tied, then most wins
 - 3. if tied, then most ties
 - 4. if tied, then fewest games played
 - 5. if tied, then Least Goals Against
 - 6. if tied, then Coin Toss
- b) Teams shall be awarded:
 - 2 points for a win
 - 1 point awarded for a tie
 - 0 points for a loss
- c) "Highest Winning Percentage" shall be calculated as:
 - Total Points received divided by Total Possible Points.
- d) "Total Possible Points" shall be defined as the number of games the team was scheduled to play minus any games not played and approved by the commissioner (i.e. not forfeited). For clarity a forfeited game counts as a game played.
- e) In the event of a forfeited game, the non-offending team shall be awarded a goal and shall be awarded 2 points in league standings.

- d) The team that is found to have played an ineligible player during a regularly scheduled game (league, tournament, or exhibition and provincial) shall forfeit all games won during which said player was a participant. This includes reversing any standings points that were awarded for all games won with said player on the active roster.

Application for entry must be submitted in writing to the League Chair by March 31 in order to participate in the subsequent season. The application must be accompanied by association boundaries, a list of committed players, division(s) teams will be declared in, list of executives, list of coaches, list of officials (certified field lacrosse officials), association colours and logo (to be approved by League Executive) and the league fee as set by the PCFLL.

RATIONALE

Previous section listed as "teams" however, this doesn't appear to make sense as teams are not individually approved to the league as expansion candidates. This section appears to apply to new league members which would be at the association level.

Q.06 Association Head Official

- a) Each association in PCFLL must have a Head Official or designated adult supervisor. This position will be the point of contact responsible for disseminating communication to the officials and coaches within the association and to provide support to the club officials. This person, or a designate, will need to be at the field each week for home games.
- b) Associations must report the name of this individual to the PCFLL Youth Head Official, the Youth Officials Allocator, and the PCFLL Executive.
- c) Associations that do not fill this position and report it as per section b) may not be scheduled for home games at the discretion of the PCFLL.

RATIONALE

Communication to the officials and coaches needs to increase. Clubs need a point person for recruitment. With many youth officials, each club/association needs to have an adult at the field during home games. Ideally this adult would be a trained official who can mentor the younger officials, but at very least is an adult presence who is able to support the officials, has the official's back and can address spectator issues where a youth official is not able to.

- b) Players that are called up must fulfill their obligation to their own team's scheduled game before committing to play for another team.
- c) All call up players must be clearly entered onto the game sheet, at the bottom of the team roster. Players being called up must be written in the game notes. One game call-up sheets must be used for all call-up players. The one game call-up sheets must be with the game sheet prior to the start of the game and stay with the game sheet. The winning team is responsible to send in all call-up sheets along with the game sheet to their commissioners.

T.02 Releases

- a) Where no team is available within the player's age group, the player must properly register with his/her home association and then obtain a release and with written release from his/her home association for the current playing season only. This release will not count as a grandfathering year. The player will be placed by the League Executive.
- b) No player may play with two associations in any given year unless the player who is already signed with an association moves to another area during the playing season. He/she must then receive permission from the Division Commissioner of his/her new area before he/she is eligible to play with a team in the new area. If the move is within the PCFLL area, permission of the move must be by the PCFLL Executive.
- c) If a player does not want to play for their home association, the player must obtain a release from their home association. With written permission of the player's home association, the League Executive will place the player.
- d) No release will be looked at except for teams that are full, i.e. a youth team has 23 players registered or a women's team has 18 players.
- e) If there is a dispute between associations concerning the release of a player, the PCFLL Executive will have the right to place the transferring player with the association that they feel is in the best interest of the League and the player.
- f) Releases will not be reviewed unless the player wishing a release is properly registered with their home association.

PROPOSED AMENDED REGULATIONS

- a) Where there is no team available within the Player's age group:
 - i) The player must properly register with their home association and then request a release
 - ii) Where there is no team for the player, associations must not unduly deny releases for players
 - iii) Release from their home association will be for the current playing season only
 - iv) This release will not count as a grandfathering year
- b) No player may play with two associations in any given year unless the player who is already signed with an association moves to another area during the playing season. They must then receive permission from the Division Commissioner of their new area before they are eligible to play with a team in the new area. If the move is within the PCFLL area, permission of the move must be by the PCFLL Executive.
- c) If a player does not want to play for their home association, the player must obtain a release from their home association.

Associations are not obligated to grant releases if the team or teams at the players age group are not full.

- d) Where associations approve releases, the PCFLL Executive is not obligated to process releases based on T.02 c) except for teams that are full, i.e. a youth team has 23 players registered or a women's team has 18 players.
- e) If there is a dispute between associations concerning the release of a player, the PCFLL Executive will have the right to place the transferring player, including denying the release.
- f) For all releases, regardless of reason for the release, the PCFLL Executive will place players within associations and on teams that are in the best interests of the League and the player and player's family.

RATIONALE

 - i. Any player may appeal a denial by their home association to the PCFLL through their League Chair within 14 days of the written notification of denial.

 - i. Any player who wishes to appeal their placement by the League Executive must do so in writing within 7 days of notice of release.
 - ii. Written notice of appeal must be sent via email to League Chair and must include relevant supporting documentation along with a \$100.00 appeal fee (payable to PCFLL). Appeal fee must be received within 72 hours of notice of appeal.
 - iii. League Executive will appoint a three (3) member Appeals Committee to review appeal and all relevant supporting documentation.
 - iv. If Appeals Committee approves the appeal, the appeal fee will be returned to the player and League Executive must release the player based on the recommendation of the Appeals Committee.
 - v. If Appeals Committee denies the appeal, the appeal fee will not be returned and the player must report to the originally assigned team or file a further appeal with the BCLA (refer to BCLA Appeal Process Appendix A General Operating Policy).
 - vi. All appeals must first be submitted to PCFLL prior to submission to BCLA.

PROPOSED AMENDED REGULATIONS

- T.04. Release Appeals
- a) Denial by Home Association
 - i. Any player may appeal a denial by their home association.
 - ii. Written notice of appeal must be sent via email to League Chair and must include relevant supporting documentation.
 - iii. Appeals must be received within 14 days of the written notification of denial (for clarity: "within 14 days" means no later than two weeks from the date of the denial as recorded on the release).
- b) Appeal of Placement by League Executive
 - i. Any player who wishes to appeal their placement by the League Executive must do so within 7 days of the notice of placement.
 - ii. Written notice of appeal must be sent via email to League Chair.
 - iii. Relevant supporting documentation and a \$100.00 appeal fee payable to PCFLL are required to proceed with an appeal. The appeal fee must be received within 72 hours of notice of appeal. The PCFLL will provide payment details to the appellant. Fees not received in the specified time will result in the appeal being cancelled.
 - iv. League Executive will appoint a three (3) member Appeals Committee to review the appeal and all relevant supporting documentation.
 - v. If the Appeals Committee approves the appeal, the appeal fee will be returned to the player and the League Executive must release the player based on the recommendation of the Appeals Committee.
 - vi. If the Appeals Committee denies the appeal, the appeal fee will not be returned, and the player must report to the originally assigned team or file a further appeal with the BCLA (refer to BCLA Appeal Process Appendix A General Operating Policy).
 - vii. All appeals must first be submitted to PCFLL prior to submission to BCLA.

This is a starting point towards the vision to see more officials developed. Eventual goal is that every club will have 2 certified officials per team capable of the team's level.

BB. Playing Season

The playing season may start as early as the first (1st) weekend after Labour Day and may continue as late the final weekend of March of the following year. All scheduled and rescheduled games between the start of the season and until mid-December will be considered the Fall season. A winter break will run from mid-December until early January of the following year. The regular winter season begins in early January and may continue until the final weekend of March.

a) Exhibition Games

Exhibition games may be scheduled at any time during the playing season with the permission of the League Commissioner.

b) Points

League play points shall be determined as follows:

- i) 2 points awarded for a win
 - 1 point awarded to each team for a tie
 - 0 points awarded for a loss

c) Forfeited Games

- ii) i) In the event of a forfeited game, the non-offending team shall be awarded one (1)a goal and shall be awarded 2 points in league standings. As per Regulation O.
- iii) The offending team shall be fined \$100.00 (or \$200.00 if less than 24 hours' notice of forfeiture) and the non-offending team shall be awarded cost associated with the game (i.e. umpire fees, field cost) when a team forfeits a game by failing to appear for the scheduled game.

- a) The playing season for Women will follow Section F with the following exceptions / deviations:
