Reports

Chair:

- Since our last meeting the Phase 3 plans have been released by BCLA
- If anyone has questions, please pose them now and we can forward the questions
- BCLA has put through notice that teams will be maxed at 20 players and if any team wishes to apply for oversized (up to 23) they must do so through PCFLL
- Maximum 2 team staff on the sidelines during a game. One of them must be a head coach and the other can be assistant coach, trainer, manager
 - If your second staff is a trainer or manager they cannot coach players at all and if head coach is tossed from the game, they cannot take over the bench
 - Recommended that second person be a trained coach to avoid these issues
- Field directorate will be setting a deadline for which all coaches must have completed their training by to be able to coach this season
- Line of Communications
 - When parents have questions, they need to go to their home association. They should not be contacting the BCLA directly
 - Parent>Home Association>PCFLL>Field Directorate>BCLA Execs

- BCLA will not be accepting US players this season
- Kelly would like to know how many clubs are barring players with compromised immune systems from playing this season
 - This is not something that is in the guidelines
 - If they are cleared by a physician to play with their condition, you cannot deny them

1st Chair:

- Stacy will be creating cohorts for the girls and Kelly for the boys
- Once all the teams are declared, our executive will go through the tiers and numbers and assign cohorts
- Stacy will be working with Karen Hertslet and Stacy Hemmerling to work on proper placement
- You cannot call up players from a lower division at all this season
 - BCLA will allow players to be shared within the same cohort
 - Not share how often this will work with schedules
 - Up to the coach of the team if they will allow their player to play for another cohort team
 - Allow 4 intracohort players per team per game
 - Need to revamp the call up form to reflect the new intracohort exchange of players
 - Suggested the player exchange only be allowed if you have 10 players or less
 - If a team is found to be using players from another club to stack your team, they should be suspended
 - If you have more than one team in the same division can we call up from the other team
 - Not unless they are in the same cohort group
 - If you have multiple teams in the same division, will they be in the same cohort
 - They will be practicing together at home but not in the same cohort for games
 - Teams should be separated on the field and not practicing together unless they are in the same cohort. Make sure there is at least 10 feet separating each distinct team which separate entrances/exits for each team
- No sharing of equipment this season
 - Dpoles cannot hand off their long pole to a middie if they take a penalty

2nd Chair:

- Nothing to report. Just waiting for numbers so they can begin working on cohorts

- How to fill out contact tracing forms
 - Could we possibly streamline the system so that we can have a sticker to put on the page and cross off those not there?
 - Managers should have roster lists with the entire contact info
 - Contact lists have to be given to the commissioners so we could just share those lists with the other 3 teams in your cohort
 - Some municipalities request contact info from spectators as well.
 - Some cities include spectators in the maximum 50 at a gathering
 - Must follow rules for your city and communicate that with other teams in your cohorts so they can pass the info to parents

- Port Coquitlam
 - How will we be posting score this season?
 - Roger was hoping to go electronic but we do not have enough time to do now
 - Roger will take this question to the FD for there input
- Delta
 - When are releases going to be completed?
 - Roger confirms they will all be done within a couple week
 - We have to go through the FD
 - Get releases in as soon as possible
