Executive Reports

Chair

- Welcome to new reps and welcome back to those continuing on. Thank-you to the exec members continuing on for welcoming Cal and I to the leadership group.
- Our goal is to try to plan ahead as far as possible and to bring issues and topics to the membership for discussion and solution. We are going to try some new and different things and if they aren't working, we will pivot away from them or make other changes to continue to improve.
- We will try to keep the meeting short tonight and our focus will be on what our start to the season looks like.
- Not trying to finalize these dates / proposals tonight. Please take them back to your respective clubs and we will have a final discussion and decision at the June League meeting.
- The Field Directorate does not meet in May, so do not have any other information other than the email that Jerry sent out recently.
- Proposed Schedule
 - The executive is proposing that we anchor our planning around the start of play on the September 18th/19th weekend.
 - Our plan is to move in 3-week increments starting on Friday, August 27th. If we do not have guidance on the 27th, we will push our starting weekend by 1 week and begin with skills and drills. If we receive guidance the following week (i.e. August 31) we will begin play on September 25th/26th. We will continue this pattern until we receive permission to play.
 - We believe that this should be sufficient to:
 - Place teams into tiers / divisions
 - Produce a 1-3 week schedule for tiering (if not in cohorts)
 - Have certified coaches
 - Have certified officials
 - If there are several weeks of delay and we can do this preparation work in advance, we can review
 what is needed to shorten the 3-week timeline (i.e. if coaches and officials are certified and teams
 have been placed into tiers / divisions, we may only need 1 week to plan the schedules etc.)
- Declaration Deadlines
 - Soft Tiering will be done via email the week of August 23rd. Details will follow. Field Times for games must be emailed to the Secretary as soon as possible
 - Final Declaration meeting and voting for tiers and oversize will be September 7 regardless of when the start of play is.

- Releases and Release Deadlines
 - The exec would like to propose to membership that each season we set two hard dates to have releases to the league by, and then after the last date, releases are done on a first come-first serve basis, as Exec has time to process.
 - Here's the proposed dates;
 - First Release deadline: Aug 29th
 - Last Release deadline: Sept 12th
 - After Sept 12, first come first serve, as Executive is able to process
 - Releases due to the Secretary by 11:59pm on deadline day.
 - PCFLL Executive will process by the Tuesday following each deadline.
 - Field Directorate also has to approve and League cannot control timeline
 - Having set dates will allow for predictability for clubs and families. It should give the executive a bird's eye view of where to place players.
- Clubs are still able to discuss how teams may fit given certain numbers, field time, and coaching situations
 but players must be released unless Field Directorate approval is in place for any type of combined club.
 - o At this time, only Vancouver/Richmond are the only combined club with FD approval.
 - o Teams combining would need to supply that info at the same deadlines as declarations
