Process for Registration & Reservation for Teams

Once your team has decided to join u, a coach, admin, team owner, etc. must register the team online at <u>http://weplay4thecause.org/team-registration</u> and pay the **non-refundable \$25 to hold your spot** [limited team spots available].

Players will register online at <u>http://weplay4thecause.org/tos-forms</u> and select the team they will be playing on and pay the **\$250 non-refundable deposit**.

If you are guest of player [non-player], you must also register and pay your deposit at http://weplay4thecause.org/tos-forms.

Payments are also made at <u>http://weplay4thecause.org/tos-forms</u>. You may pay in full or choose the amount you wish to pay and when. BALANCES ARE DUE ON OR BEFORE MARCH 1, 2026. Along with their deposit payment, guests will be required to provide the following information to be added to the group manifest:

Taxes, Fees and Port Expenses (included)

Taxes and Fees \$113.78 per person

Royal Caribbean International shall be prepaid for all departure taxes, custom fees, airport facility charges, and any and all other applicable fees in effect at the time of sailing. The Fees are subject to change without notice.

Gratuities (in Error! Reference source not found.)

When booking, we recommend that gratuities be prepaid at the current rate of **\$74.00 per person** for the entire cruise. *For guests booked within suite staterooms, our current gratuity rate is **\$84.00 per person**.

**If not prepaid prior to sailing, they will be automatically added to each guest's SeaPass account once onboard.

Note: These gratuities are shared among dining, culinary services staff, stateroom attendants, and other hotel services teams who work behind the scenes to enhance the cruise experience.

Pregnancy and Infants

Royal Caribbean International cannot accept guests who will be more than 23 weeks pregnant at any time during the cruise or Cruise Tour. Guests will be required to fill out a Public Health Questionnaire prior to arrival or at the pier attesting that they are not more than 23 weeks pregnant.

Infants sailing on a cruise must be at least 6 months old as of the first day of the cruise and/or CruiseTour. For transatlantic, transpacific, Hawaii, select South American and other selected cruises and/or CruiseTours, the infant must be at least 12 months old as of the first day of the cruise/CruiseTour. For the purposes of this policy, any cruise that has 3 or more days consecutive at sea will require infants to be 12 months old on the first day of the cruise/CruiseTour.

Accessible Cruising

Upon request, every effort will be made to provide reasonable accommodations to meet the needs of our guests. Please note that not all accommodations may be able to be provided and that guests should be fit for travel. We do not require guests to travel with a companion; however, our personnel are not required to perform personal tasks.

We encourage you to notify us of your needs at time of booking, to review the availability of specific equipment or services. Please provide at least 60 days notice if you need sign language interpreting services or at least 30 days notice if you require special equipment or services. Advance notice must also be given if you are traveling with a group of 10 or more passengers with a disability. To notify us of your needs, please fill out our accommodation request form at RoyalCaribbean.com/special needs form or call our Access Department at (866) 592-7225.

Deposits and Final Payments

A non-refundable deposit of **\$250** per person is due at the time of registration and must be done through the Tournament on the Seas at http://weplay4thecause.org/registration. To secure any team spot, team owner, caption, admin, etc. must register the team. This will insure team/group pricing and tournament event, including special event.

Reservation must be made under full legal name, date of birth and full non-refundable deposit no later than **July 7**, **2025**. Any booking or deposit outside of Tournament on the Seas group, prices may vary and you will not be registered as a part of our tournament and special event. Please contact us at <u>play4thecause@gmail.com</u> if you have any questions.

Final payment for all remaining amounts is due no later than **March 1, 2026**. Any balance due after this date will result in the your cancellation and or your team cancellation. There will be NO REFUND. Everyone on the team must make final payments on or before due date in order to be added to the tournament schedule.

If you cancel, you will need to make cancellations of flights, hotel stays, other pre-booked services, or additional cruise components directly with whom you booked with.
