### Deadlines:

The deadline for amendments is November 30, 2025.

The deadline for nominations to the board and councils must be at least 21 days prior to the date of the AGM, which is January 8, 2026.

### Voting Rights:

Select Members are entitled to vote in accordance with section 1.06 k) of the OBA By-Laws.

- Loop Associations
- Select Local Community Baseball Associations
- Select Direct Entries
- Select Council Members
- Select Life Members

Rep Members are entitled to vote in accordance with section 1.06 j) of the OBA By-Laws.

- Affiliated Associations
- Rep Direct Entries
- Rep Council Members
- Life Members
- Honorary Members
- Past Presidents

Board Members are entitled to one (1) vote.

Local Members are entitled to one (1) vote.

All voting delegates will be entitled to vote with respect to the election of the President and Vice President, the amendment of the By-laws and the appointment of the auditor.

Rep Member voting delegates will elect the Rep Commissioner and Rep Directors of the Board.

Select Member voting delegates will elect the Select Commissioner and Select Directors of the Board.

### Select Member Voting:

Each member of the Select Division shall be entitled to the following votes:

Each local community baseball association which is a member in good standing	1 vote
Each recognized loop association	1 vote
Each member of Select Council	1 vote
Each Select Life member without a vote as a current member of the Select Council	1 vote

The votes under section 1.06 k) (i) count as Select Division votes.

A delegate may only cast one vote/ballot and may not cast both a Rep vote/ballot and a Select vote/ballot on the same matter.

Only delegates present are entitled to vote.

A delegate from an association in arrears to the OBA in any way shall be considered not in good standing and shall not be permitted to vote at an Annual or Special Meeting, providing notice of such arrears has been given in writing to the association a month prior to the meeting.

NOTE: For rule changes, Select Council will decide at a future meeting of Council.

## Rep Member Voting:

Each Affiliated Association in good standing shall be entitled to the following votes:

Affiliated Associations with more than 24 teams	4 votes
Affiliated Associations with 15 to 24 teams	3 votes
Affiliated Associations with 6 to 14 teams	2 votes
Affiliated Associations with 1 to 5 teams	1 vote

Board Members, Rep Direct Entries, Life Members, Honorary Members, Past Presidents and each member of Rep Council shall be entitled to one (1) vote as a Rep Member.

Total number of teams will be calculated annually based on the number of rosters submitted from all Affiliated Associations.

The votes under section 1.06 j) (i) and (ii) count as Rep Division votes.
