ASSUMPTION OF RISK, WAIVER OF LIABILITY,
RELEASE AND INDEMINIFCATION AGREEMENT

I. This Assumption of Risk, Waiver of Liability, Release and Indemnification Agreement ("Agreement") as dated below is between the below named player or participant ("The Player") or the parent/legal guardian ("Parent/Guardian") of The Player and Mesquite Outlaws Soccer L.L.C., known as the Mesquite Outlaws FC ("The Outlaws").

II. I acknowledge that soccer, whether a match, practice, exhibition, clinic, camp, fitness training or tryout ("Soccer Events"), is an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury, minor injury or property loss. I recognize that I am willingly participating in a league, camp, clinic, soccer activity or fitness activity and I HEREBY ASSUME THE RISK OF PARTICIPATION IN THE SOCCER EVENTS.

I agree that prior to participating, I will inspect the facilities and equipment to be used and if I believe anything is unsafe, I will immediately advise the coach, referee or supervisor of such condition(s) and refuse to participate. I acknowledge that it is IMPOSSIBLE TO ELIMINATE ALL RISK AND POSSIBILITY OF INJURY. I agree that The Player possesses a sufficient level of skill, physical fitness and understanding of the rules of soccer to safely participate in Soccer Events. The Player agrees to notify The Outlaws of any known injuries, physical limitations or impairments prior to participating in Soccer Events.

- III. I, The Player, hereby take the following action for myself, my executors, administrators, heirs, next of kin, successors and assigns:
a) I WAIVE, RELEASE, AND DISCHARGE from any and all claims or liabilities for death, personal injury, property loss or damages of any kind, which arise out of or relate to The Player's participation in, or traveling to and from the Soccer Events, THE FOLLOWING PERSONS OR ENTITIES: The City of Dallas, The City of Dallas Parks and Recreation Department and The Outlaws, which includes the Team Owners; Sponsors; Co-Participants; Coaches; Officers; Directors; Employees; Volunteers; Representatives and Agents or any Officer, Director, Employee, Volunteers, Representatives or Agents or its affiliated entities.
b) I AGREE NOT TO SUE nor bring any type of lawsuit against The City of Dallas, The City of Dallas Parks and Recreation Department and The Outlaws, which includes the Team Owners; Sponsors; Co-Participants; Coaches; Officers; Directors; Employees; Volunteers; Representatives and Agents or any Officer, Director, Employee, Volunteers, Representatives or Agents or its affiliated entities for any of the claims or liabilities that I have waived, released or discharged herein; and
c) I INDEMNIFY AND HOLD HARMLESS The City of Dallas, The City of Dallas Parks and Recreation Department and The Outlaws, which includes the Team Owners; Sponsors; Co-Participants; Coaches; Officers; Directors; Employees; Volunteers; Representatives and Agents or any Officer, Director, Employee, Volunteers, Representatives or Agents or its affiliated entities from any claims made or liabilities assessed against The Outlaws as a result of my actions.

I hereby affirm that I, The Player, am eighteen (18) years of age or older and I have read this document and I understand its contents. I, The Player, understand that I have given up substantial rights by signing this document and sign it voluntarily.

I, The Player, AM UNDER THE AGE OF EIGHTEEN (18) YEARS OLD. MY PARENT/GUARDIAN HAS READ AND COMPLETED SECTION IV BELOW. (If The Player is under 18 years of age, a parent or guardian must execute, the entire Agreement, including the following section IV for and on behalf of the minor.)

IV. The undersigned, _____ (Parent/Guardian) the parent and natural guardian or legal guardian of _____ (minor Player's name) hereby accept this Agreement for and on behalf of The Player, a minor. I hereby bind myself, the minor Player and all other assigns to the terms of the Agreement. I represent that I have legal capacity and authority to act for and on behalf of the minor Player in the execution of the Agreement. I hereby authorize any licensed physician, emergency medical technician, hospital or other medical or health care facility to treat the minor Player named herein for the purpose of attempting to treat or relieve any injuries received by the minor Player arising out of, or relating to any Soccer Event. I authorize any such medical provider to perform all procedures deemed medical advisable. I realize and appreciate that there is a possibility of complications and unforeseen consequences in any medical treatment, and I assume any such risk for and on behalf of myself and the minor Player and relieve The Outlaws of any responsibility related to that care.
