The definition of non-editorial "commercial use" includes, but is not limited to: the licenses, permission, authorization or sale of the Photographs or Recordings for distribution or exhibition on film, network, satellite, cable or any form of television, CD, CD-ROM, cassette, vinyl, digital transmission via the Internet, merchandising, print publication, in-store broadcasts, in-house use or any other use, licensing or sale of the Photographs or Recordings for non-editorial use in any media, now known or hereafter created. If any other use of the Photographs or Recordings is desired, we agree to obtain the prior written consent of Ontario Pro Soccer.

3.
