

**2021 ONTARIO FURY PRE-SEASON SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE OR PAYMENT REQUIRED TO ENTER OR WIN.**

**SWEEPSTAKES VOID WHERE PROHIBITED.**

The details of the prizes and how to enter the Sweepstakes are contained in these Official Rules.

**ELIGIBILITY.** The 2021 Ontario Fury Pre-Season Sweepstakes (the “Sweepstakes”) is only open to residents of California, who are 18 years of age or older at time of entry. Void where prohibited by law. Employees of Ontario Fury and the Major Arena Soccer League (“MASL”) and its member teams, and each of their respective affiliates, owners, subsidiaries, advertising, or promotion agencies are not eligible, nor are members of these employees' families (defined as parents, children, siblings, spouse, and life partners) and members of the same household, whether related. Proof of residency and age may be required.

**TIMING.** The Sweepstakes begins at 10:00 a.m. Pacific Standard Time (“PST”) on November 14, 2021 and ends at 11:59 p.m. PST on November 28, 2021 (“Promotion Period”). Entries received after the Promotion Period are disqualified.

**TO ENTER.** Limit one (1) entry per person, per email address, as applicable.

1. **Link:** Access to the sweepstakes is through a link distributed by social media and email. If you receive an email from the Ontario Fury during the Promotion Period, click on the banners, buttons and/or links to access the online entry form for the Sweepstakes and complete all required information. By submitting your completed online entry form as directed, you will receive one (1) entry in the Sweepstakes. Entrants must fully complete and submit all non-optional data requested in the online entry form to be eligible. Incomplete entries are void. The Ontario Fury are not responsible for lost, late, incomplete, garbled, illegible, or misdirected Sweepstakes entries, or for any error, human, technical or otherwise, which may occur in the processing of Sweepstakes entries. Proof of sending will not be deemed to be proof of receipt. All entries become the exclusive property of The Ontario Fury and will not be acknowledged or returned. Any use of robotic, automatic, programmed or similar entry methods will void all such entries by such methods.

More than one (1) entry from any person, household, or from any e-mail address will void all entries from that person or e-mail address as applicable. Any attempt by a person to enter more than once with multiple email accounts or mailings may result in disqualification at the discretion of The Ontario Fury upon verification of prize winners.

**USE OF DATA.** The Ontario Fury will be collecting personal data about participants (including, without limitation, name, phone number, mailing address, gender, age e-mail addresses) when they

enter the Sweepstakes online. By participating in the Sweepstakes, entrants hereby agree to all personal information uses and disclaimers.

**AGREEMENT TO OFFICIAL RULES.** Participation in the Sweepstakes constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules.

**SELECTION OF POTENTIAL WINNERS.** Three (3) Winners (each a "Winner," and collectively, the "Winners") will be selected at random on or about November 28, 2021. Winners will be notified via telephone or email on or about November 28, 2021. Ontario Fury's decisions as to all matters related to administration of the Sweepstakes and selection of the Winners is final. Potential Winners must comply with all terms and conditions set forth in these Official Rules and winning and award of prizes is contingent upon fulfilling all requirements. If a potential Winner cannot be contacted within FORTY-EIGHT (48) hours after the first attempt to contact such potential Winner, an alternate entrant will be selected in his or her place at random from all eligible entries received.

**PRIZES:** Three (3) Prizes will be awarded in all (each a "Prize," and collectively, the "Prizes"). Each Winner will receive one (1) of the following Prizes based on the order in which each Winner is randomly selected:

Prize #1: One (1) Winner will receive one (1) New Ontario Fury jersey signed by one or more of the players of the 2021-2022 Ontario Fury and VIP suite access to one (1) of the select home game at Toyota Arena.

Prize #2: One (1) Winner will receive one (1) Ontario Fury Soccer Ball, signed by one of the 2021-2022 players, one (1) Ontario Fury scarf, and four (4) tickets to any home game.

Prize #3: One (1) Winner will receive one (1) Championship Bound T-Shirt

Odds of winning depend on the number of eligible entries received during the entire Promotion Period.

Except where otherwise expressly noted in these Official Rules, the selection of all vendors, prizes, products and services is subject to the Ontario Fury's sole and absolute discretion. Prizes (and/or any portion thereof) are nontransferable and non-exchangeable. No substitutions or cash redemption of Prizes are permitted except that the Ontario Fury retain the right to substitute a prize of equal or greater retail value (or at the Ontario Fury's election, the cash value of the applicable prize). Additional restrictions may apply.

**GENERAL CONDITIONS.** The Sweepstakes is governed by the laws of the United States and the State of California, excluding conflicts of laws principles. All federal, state and local laws and regulations apply. Sweepstakes void where prohibited. Sweepstakes may only be entered in or from California and entries originating from any other jurisdiction are not eligible for entry.

Except where prohibited by law, each Winner grants to the Ontario Fury and its advertising

agencies the right to use and publish each Winners' photo, proper name, likeness, voice, opinions, biographical information and state in any media to promote the Sweepstakes without additional compensation.

By entering, participants release, indemnify and hold harmless the Ontario Fury the MASL and its member teams, and each of their respective subsidiaries, affiliates, owners, members, shareholders, directors, officers, employees and agents (collectively, the "Releasees") from any and all liability for any injuries, loss or damage of any kind, including death, arising from or in connection with the Sweepstakes or receipt or use and/or misuse of any prize.

**WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, THE PRIZES ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, AND THE RELEASED PARTIES HEREBY DISCLAIM ALL SUCH WARRANTIES, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND/OR NON-INFRINGEMENT.**

The Ontario Fury reserves the right to cancel or modify the Sweepstakes if fraud or any other factor impairs the integrity of the Sweepstakes as determined by Sponsor in its sole discretion.

Online entries are deemed made by the authorized account holder of the e-mail address submitted at the time of entry. The "authorized account holder" is deemed the natural person who is assigned to an e-mail address by an Internet access provider, service provider or other online organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. A potential winner may be requested to provide Sponsor with proof that the potential winner is the authorized account holder of the e-mail address associated with the winning entry and is a California resident. Prizes will only be awarded to the authorized account holder.

If, in the Ontario Fury's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Sweepstakes, or if technical difficulties compromise the integrity of the Sweepstakes, the Ontario Fury reserves the right in its sole discretion to void any entries at issue (including disqualifying any individual who tampers or otherwise interferes with the entry process), and to cancel, terminate, modify or suspend the Sweepstakes, in whole or in part, at any time without notice. In the event of such cancellation, the Ontario Fury reserve the

right to award prizes in a random drawing from all eligible entries received before the time of cancellation.

The Ontario Fury in no way promotes illegal acts, and any and all entries which include or promote illegal acts will be disqualified. The Ontario Fury assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction of unauthorized access to, or alternation of, entries.
