

RELEASE OF LIABILITY, ASSUMPTION OF RISK, AND WAIVER AGREEMENT

RELEASE AND ASSUMPTION OF RISK

In consideration of being permitted to participate in any activities, events, training sessions, tryouts, or use of facilities affiliated with Phoenix Pulse FC, and mindful of the inherent and significant risks associated with such activities, I, for myself, my heirs, my estate, and my personal representatives, do hereby fully and forever release and discharge Phoenix Pulse FC, Moon Ventures Group LLC, and their respective owners, employees, coaches, directors, officers, agents, sponsors, volunteers, contractors, and affiliates (collectively referred to as "Phoenix Pulse FC") from any and all liability for personal injury, property damage, or wrongful death that may arise from my participation or use of said facilities.

I knowingly waive and relinquish any and all claims, causes of action, or demands, whether known or unknown, arising from participation in any Phoenix Pulse FC activity, whether caused by the negligence of Phoenix Pulse FC or otherwise. This release applies to all present and future participation.

ACKNOWLEDGMENT OF RISK

I understand and acknowledge that participating in indoor soccer, athletic training, fitness activities, or related events hosted by Phoenix Pulse FC involves significant risks, including but not limited to: slips, trips, falls, collisions, equipment failure, player contact, and acts or omissions of other participants, staff, or facility conditions.

I understand that these risks may result in serious injury, illness, permanent disability, or even death, and I voluntarily assume all such risks, both known and unknown.

MEDICAL AUTHORIZATION

I hereby authorize Phoenix Pulse FC and its representatives to secure emergency medical treatment on my behalf (or on behalf of any minor child for whom I am responsible) in the event of injury or illness while participating in any team-related activities. I agree to be responsible for any and all medical and emergency costs incurred as a result of said care.

PROMOTIONAL RELEASE

I grant Phoenix Pulse FC and its representatives the right to photograph, video, or otherwise capture my (or my minor child's) participation for promotional, commercial, and social media purposes. I understand that all such media will remain the property of Phoenix Pulse FC and may be used without compensation. I also authorize Phoenix Pulse FC to contact me via email, phone, or mail regarding team announcements, promotions, and event updates.

ACKNOWLEDGMENT AND ACCEPTANCE
